## **NOTICE OF PROPERTY TAX INCREASE**

The Demorest City Council has tentatively adopted a millage rate which will require an increase in property taxes by 16.51% percent.

All concerned citizens are invited to the public hearing on this tax increase to be held at Demorest Municipal Conference Center, 250 Alabama Street, Demorest, Georgia on October 26, 2023 at 6:00 p.m.

Times and dates of additional public hearings are as follows: October 19, 2023 at 6:00 p.m. and October 26, 2023 at 12:00 p.m. also located in the Demorest Municipal Conference Center.

This tentative increase will result in a millage rate of 6.16 mills, an increase of .873 mills. Without this tentative increase, the millage rate will be no more than 5.287 mills. The proposed tax increase for a home with a fair market value of \$175,000 is approximately \$61.11 and the proposed tax increase for nonhomestead property with a fair market value of \$225,000 is approximately \$78.57.
